

IMMEDIATE RELEASE STOCKTON-LODI METROPOLITAN STATISTICAL AREA (MSA) (San Joaquin County)

The unemployment rate in San Joaquin County was 6.6 percent in April 2024, down from a revised 7.2 percent in March 2024, and above the year-ago estimate of 5.6 percent. This compares with an unadjusted unemployment rate of 4.8 percent for California and 3.5 percent for the nation during the same period.
