Multi-agency adoption of a policy to promote economic development by capitalizing on current and projected local an regional induced demand for Green products and services. 2. Develop infrastructure and incentives for public and private investment in financing the Green sector. 3. Develop a network to promote the production, diffusion, and adaptation of knowledge to ensure that a region has an edge in innovation. 4. Match training to labor needs for the Green sector through utilizing community colleges and Workforce Investment Boards. 5. Eliminate cumbersome city rules and regulations that hinder the development of the Green sector and/or expansion of Green firms and Green industrial/service cluster. 6. Maintain accountability by developing performance measurements and a monitoring strategy. 7. Incorporate priorities for community economic development. 8. Support organization and leadership to direct growth in the Green sector. The authors provide no exact definition. However, they note that the Green sector "can be
"Green"	conceived as being composed of activities related to efforts to clean the air and water, manage waste products, promote conservation, and enhance the environment."
Methodology	The overall goal of this report was to develop policy recommendations to guide development in the Green sector. The authors listed the following criteria around which the recommendations should be centered: 1. Demonstrate success in regions. 2. Be appropriate to scale for a large city. 3. Cost effective. 4. Connected to meaningful opportunity for change in a region. 5. Projected to help foster equity and inclusion. 6. Designed for the short-term. 7. Focus on demand-oriented strategies. 8. Industry-based approach. 9. Include community benefits principals.
