Summary	The report presents the findings of a Center of Excellence's case study, whose main purpose was to determine the "opportunities for training in green industries using existing industries and occupations as the base." The process to determine this involved gathering information on emerging green jobs and green industries (using NAICS and SOC codes), and then using these data to identify which areas need more training, and will need more training in the future. Community Colleges can then use this information to alter and improve their green training programs.
